NOTIFICATION OF THE ELECTRONIC TRANSACTIONS DEVELOPMENT AGENCY NO. DPS. 2/2566 RE: FORMS FOR PRIOR NOTIFICATION OF THE OPERATION OF DIGITAL PLATFORM

SERVICE BUSINESSES THAT ARE SUBJECT TO PRIOR NOTIFICATION UNDER SECTION 8 PARAGRAPH ONE AND FORMS FOR NOTIFYING BRIEF DETAILS FOR DIGITAL PLATFORM SERVICES UNDER SECTION 8 PARAGRAPH FOUR

Whereas it is expedient to prescribe forms for prior notification of the operation of digital platform service businesses that are subject to prior notification under section 8 paragraph one and forms for notifying brief details for digital platform services under section 8 paragraph four;

By virtue of the provisions of section 6, section 8 paragraph four and section 12 paragraph two of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), the Director of the Electronic Transactions Development Agency hereby issues the Notification, as follows.

Clause 1. This Notification is called the "Notification of the Electronic Transactions Development Agency No. DPS. 2/2566 Re: Forms for Prior Notification of the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification under Section 8 Paragraph One and Forms for Notifying Brief Details for Digital Platform Services under Section 8 Paragraph Four".

Clause 2. This Notification shall come into force as from the 21st day of August B.E. 2566 (2023).

Clause 3. In this Notification:

"Business Notification System" means the system for notifying the operation of digital platform service businesses made available by the Agency through the electronic means;

"person wishing to operate the business" means a person who intends to operate a digital platform service business that is subject to prior notification under section 8

paragraph one of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

"person wishing to operate the business under section 8 paragraph four" means a person who intends to operate a digital platform service business that does not possess the characteristics under section 8 paragraph one or is exempted under section 8 paragraph three of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

"Agency" means the Electronic Transactions Development Agency;

"Competent official" means the Director of the Electronic Transactions Development Agency or a person appointed by the Director of the Electronic Transactions Development Agency for the execution of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022).

Clause 4. The person wishing to operate the business shall notify the information and submit the evidence under section 12 of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), as listed in the Form for Prior Notification of the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification under Section 8 Paragraph One and the Information Form for Digital Platform Services under Section 8 Paragraph One annexed to this Notification, through the Business Notification System, or by making the submission to the competent official at the address of the Agency.

Clause 5. The person wishing to operate the business under section 8 paragraph four shall notify the information and submit the evidence of the brief details under section 12 (1), section 12 (2) (a), (b) and (c) and section 12 (5) of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), as listed in the Form for Notifying Brief Details for Digital Platform Services under Section 8 Paragraph Four and the Information Form for Digital Platform Services under Section 8 Paragraph Four annexed to this Notification, through the Business Notification System, or by making the submission to the competent official at the address of the Agency.
