NOTIFICATION OF THE ELECTRONIC TRANSACTIONS DEVELOPMENT AGENCY

NO. DPS. 3/2566

RE: FORMS FOR ANNUAL NOTIFICATION OF INFORMATION
ON THE OPERATION OF DIGITAL PLATFORM SERVICE BUSINESSES
AND NOTIFICATION OF CHANGE TO THE INFORMATION

Whereas it is expedient to prescribe forms for annual notification of information on the operation of digital platform service businesses and notification of change to the information;

By virtue of the provisions of section 6, section 8 paragraph four, section 12 and section 15 of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), the Director of the Electronic Transactions Development Agency hereby issues the Notification, as follows.

Clause 1. This Notification is called the “Notification of the Electronic Transactions Development Agency No. DPS. 3/2566 Re: Forms for Annual Notification of Information on the Operation of Digital Platform Service Businesses and Notification of Change to the Information”.

Clause 2. This Notification shall come into force as from the 21st day of August B.E. 2566 (2023).

Clause 3. In this Notification:
“Business Notification System” means the system for notifying the operation of digital platform service businesses made available by the Agency through the electronic means;

“operator” means a person who operates a digital platform service business that is subject to prior notification under the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

“operator under section 8 paragraph four” means an operator of a digital platform service business that does not possess the characteristics under section 8 paragraph

one or is exempted under section 8 paragraph three of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

“Agency” means the Electronic Transactions Development Agency;

“competent official” means the Director of the Electronic Transactions Development Agency or a person appointed by the Director of the Electronic Transactions Development Agency for the execution of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022).

Clause 4. The operator shall notify the information and submit the evidence under section 12 of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), as listed in the Form for Annual Notification of Information and Notification of Change to the Information for Digital Platform Services under Section 8 Paragraph One annexed to this Notification, through the Business Notification System, or by making the submission to the competent official at the address of the Agency.

Clause 5. In the case where the operator has made a change to any information under section 12 (1), section 12 (2) (a), (b) or (c) or section 12 (5) of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), including a change due to a business acquisition, a transfer of business, a merger or any other similar undertaking other than cessation of business, the operator shall notify the Agency within thirty days from the date on which the information is changed. In this regard, the information shall be notified as listed in the Form for Annual Notification of Information and Notification of Change to the Information for Digital Platform Services under Section 8 Paragraph One annexed to this Notification, through the Business Notification System or by making the submission to the competent official at the address of the Agency.

Clause 6. The operator under section 8 paragraph four shall notify the information and submit the evidence of the brief details under section 12 (1), section 12 (2) (a), (b), (c), (d) and (e), section 12 (3) (b) and section 12 (5) of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022) as listed in the Form for Annual Notification of Information for Digital Platform Services under Section 8 Paragraph Four annexed to this Notification, through the Business Notification System or by making the submission to the competent official at the address of the Agency.
