NOTIFICATION OF THE ELECTRONIC TRANSACTIONS DEVELOPMENT AGENCY  
NO. DPS. 5/2566  
RE: TERMS AND CONDITIONS REPORTING FORM FOR DIGITAL PLATFORM SERVICES

Whereas it is expedient to prescribe terms and conditions reporting form for digital platform services to comply with the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

By virtue of Section 17 paragraph four of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022), the Director of the Electronic Transactions Development Agency hereby issues the Notification as follows:

**Clause 1.** This Notification is called the “Notification of the Electronic Transactions Development Agency No. DPS. 5/2566 Re: Terms and Conditions Reporting Form for Digital Platform Services”.

**Clause 2.** This Notification shall come into force as of 3<sup>rd</sup> January B.E. 2567 (2024).

**Clause 3.** In this Notification:  
“operator” means a person who operates digital platform service business that possesses the characteristics in accordance with section 16 of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);  
“Agency” means the Electronic Transactions Development Agency;  
“Competent official” means the Director of the Electronic Transactions Development Agency or a person appointed by the Director of the Electronic Transactions Development Agency for the execution of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022);

“Business Notification System” means the system for notifying the operation of digital platform services made available by the Agency through the electronic means.

**Clause 4.**

This Notification applies to operators providing digital platform services that possess the characteristics in accordance with section 16 of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022).

**Clause 5.** The operator shall submit a report and evidence of the publication of the notice of terms and conditions of services for users’ knowledge in accordance with section 17 paragraph one of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022) to the Agency. The submission shall be made concurrently with the annual notification of information on operations of the digital platform service business every year. Such report shall contain the information as listed in the Form for Reporting the Publication of Notice of Terms and Conditions for Users’ Knowledge annexed to this Notification, and be submitted through the Business Notification System or filing the Form to the competent official at the Agency’s principal office.

**Clause 6.** The operator shall submit a report and evidence of the notification of changes to the terms and conditions of services in accordance with section 17 paragraph three of the Royal Decree on the Operation of Digital Platform Service Businesses That Are Subject to Prior Notification, B.E. 2565 (2022) to the Agency. The submission shall be made concurrently with the annual notification of information on operations of the digital platform service business every year. Such report shall contain the information as listed in the Form for Notifying the Change of Terms and Conditions of Services annexed to this Notification, and be submitted through the Business Notification System or by making the submission to the competent official at the location of the Agency.
